<b>What is the overall <u>deductible</u>?</b>	Individual: Participating \$3,600; Non-Participating \$7,200 Family: Participating \$10,800; Non-Participating \$21,600	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family deductible.
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. In-Network Preventive Health Care services, services with a <u>copayment</u> , and prescription drugs are covered before you meet your <u>deductible</u> .
